PTA REGULATIONS GOVERNING EXHIBITS

1. No exhibitor shall assign, sublet, or apportion the whole or any part of the space allotted; nor permit any other person to exhibit therein any goods other than those manufactured or jobbed by the exhibitor in the regular course of his business; nor permit any representative or any company not exhibiting to solicit business or take orders in this space.
2. Payment for the space plus the \$100.00 refundable deposit fee must be returned to Indiana PTA with the executed copy of the Exhibitor Space Agreement and the Exhibit Registration Form.
3. Indiana Congress of Parents and Teachers Association, its employees and representatives shall not be responsible or liable for the properties of any exhibitor, nor any loss, theft, damage, injury occurring to the exhibitor, its employees or representatives. PTA will, however, use every effort to protect exhibitors against such loss. In all cases exhibitors wishing to insure their goods, must do so at their own expense.
4. All exhibits must be confined to the assigned space and must not be of such nature or arrangement as to obstruct the view of or interfere with the exhibits of others. Without consent of the Exhibit Chairman, no exhibits or other construction shall exceed a maximum of 8' in background or 3' division rail height, except that background height may extend out from the booth backline not to exceed 4'. All exhibit construction must be finished or covered so as not to be unsightly to neighboring exhibitors. All exhibits higher than 3' should be displayed in the rear 4' booth depth. Public address systems cannot be used if such use interferes or disturbs other exhibitors. Only fireproof materials can be used in exhibit decoration. All electrical equipment must be U.L. approved and all gas operating equipment must be G.A. approved.
5. The management of the Indianapolis Marriott East will not allow anyone to nail, staple, tape, spray, hang or attach anything to the walls, ceilings, floors, without prior written approval, and all exhibitors shall assume responsibility for and hold PTA harmless and defend it against any said damages to the hotel.
6. Public Show Hours: **Saturday, May 5, 2012 from 10:00 a.m. until 4:00 p.m.**
7. Removal of Exhibits: Exhibitors may dismantle and remove their exhibits **after** 4:00 p.m.
8. Booths, Furniture: Approximately 8' x 10' booths are available. Included in the booth charge is an 8' background drapery and a 3' side drape, one exhibitor name sign, one draped table and one chair. The Indiana PTA will furnish name tags for the exhibitors. Exhibitors may use their own furniture and equipment or rent it from the official decorator.
9. Show Decorator: The official decorator and drapage contractor is: PTR Expo Serve, 1212 South Rangeline Road, Carmel, IN 46032 (317) 844-5178 Fax (317) 587-0797
10. Grand Prize Drawing: Indiana PTA will sponsor a drawing. To be eligible each participating delegate must have their card stamped at each booth. Indiana PTA will provide stamps.

11. Names and addresses of delegates will not be furnished by Indiana PTA. Names may be requested of delegates as they visit each booth.
12. **Booth assignments will be made the week of April 7.** No changes will be made unless an emergency situation develops. Every effort will be made to alternate exhibits so that competitors will not be side by side.
13. If your booth requires an electrical outlet, etc., you **MUST** contact the Indianapolis Marriott Hotel. A form will be enclosed in this Exhibitors Packet as well as the one sent to you by PTR Expo Serve. **This form is to be returned to the hotel and NOT the Indiana PTA Office.**
